### **Data Protection Notice**

*The Friends of Streatham Hill Theatre, its trustees, officers and management, and its volunteers and staff ('we', 'us', 'our').*

To provide our services and deliver our activities as per our constitution, rules and terms & conditions, we collect and use data about you. This data includes:

- Your name.
- Your contact details.
- Your consents.
- For membership purposes: your interests, skills, experience.
- Your enquiries.

We may monitor and record all communications with you for legal, quality control and training purposes.

In addition we may monitor and record your images or voice if you use our services or participate in any of our activities for security, archive, publicity or publishing purposes.

### **Consent**

You consent to us storing and processing the data we hold about you for the purposes of providing you with our services and delivering our activities. Key purposes include:

- Managing memberships.
- Campaigning.
- Running events etc.
- Communicating details of our services and activities.
- Communicating relevant information about us and our members, friends, supporters and associates, or other information that may interest you.
- Managing finances and payments.
- Management information, analysis and research.
- Audits, system integrity checking and risk management.

You may withdraw your consent at any time, but if you do we may no longer be able to continue to provide you with services nor access to our activities.

### **Data Protection and Privacy**

All data we hold about you is held in accordance with the applicable legislation relating to data protection and privacy. We maintain procedures and protections in the storage and disclosure of data we hold about you to keep it secure and prevent its unauthorised access or loss.

Other than to provide our services and deliver our activities, we will not disclose data we hold about you to third parties unless required by legislation or by a court of law.

### **Third Party Providers**

We may use third party entities as providers in support of our activities and it may be necessary to provide them with data we hold about you. Those providers have duties as governed by their own

privacy policies in respect of the data provided to them and we cannot accept responsibility for their actions. If you give them your consent, these providers may share your data with us.

Our key service providers (which may change from time to time) are:

- Licensing authorities and agents.

### **Geographical Area**

Data we hold about you may be transferred to entities within and outside of the European Economic Area, subject to those entities ensuring data is adequately protected.

### **Data Retention**

We may keep the data we hold about you until it is no longer required, or for as long as required by legislation. Data that is no longer retained will be securely deleted or destroyed.

If you request that we delete data we hold about you:

- We may not be able to delete that data for which retention is covered by legislation.
- We will delete data about your request and any withdrawal of consent, which may lead to us collecting your data again.

### **Your Rights**

You have certain rights under the GDPR, including:

- To request a copy of any data we hold about you.
- To correct any incorrect data we hold about you.
- To object to the use of data we hold about you.
- To withdraw your consent to use data we hold about you.
- To have your data we hold about you deleted in certain circumstances.
- To complain about the use of data we hold about you to the Information Commissioner.
