
# PRESS RELEASE EMBARGOED UNTIL 29th June 2022

Today, 29th June, Save Britain's Heritage (SAVE), has added Streatham Hill Theatre to its Buildings at Risk Register 2022 which highlights historic buildings whose future is uncertain, and ultimately seeks to return them to use and secure the buildings' futures.

David Harewood MBE and Jools Holland OBE DL have today become Patrons of The Friends of Streatham Hill Theatre campaign to find a sustainable solution to the future of the building, and promote its return to use as an arts and culture venue for the community. Other Patrons of the campaign include: Baroness Floella Benjamin, DBE, DL, Samira Ahmed, and Sir Mark Rylance.

Also today, broadcast journalism students at the University of Westminster have published online a student documentary featuring *Sherwood* star, and campaign Patron, Robert

### University of Westminster student documentary

A team of University of Westminster MA Broadcast Journalism students, led by Neha Suryavanshi, looked to make a documentary about London losing so many historic buildings, choosing to focus on Streatham Hill Theatre. ### **Streatham Hill Theatre**

Streatham Hill Theatre originally opened in 1929 and is a Grade II listed building with an auditorium with a capacity of over 2,800. It was the last project by the renowned West End theatre architect W G R Sprague, whose other surviving theatres include the Wyndhams Theatre, Noel Coward Theatre, Aldwych Theatre and Gielgud Theatre.

After a direct V1 'doodlebug' hit in 1944, it closed for the rest of WWII and reopened in 1950 to entertain visitors for another twelve years, before being repurposed for bingo in 1962, until the closure of the bingo in 2017. The theatre was added to Theatres Trust's Theatres at Risk Register in 2017.

In 2019, after a flashmob of over 1,000 people demonstrated huge local support, Lambeth Council turned down an appeal by the theatre's owners against its Asset of Community Value status.

In November 2021, Historic England <u>added Streatham Hill Theatre</u> to its national Heritage at Risk Register of most valued historic places and those most at risk of being lost. On the announcement of this, Sadiq Khan, Mayor of London said "I hope others will join me in supporting this remarkable building being transformed into an inclusive, cultural space that will serve the local community for years to come."

#### **Building Ownership**

The Friends have no access to or control of the building, which is currently only partially in use as a small slot machine lounge by leaseholders, Merkur Casino UK (formerly Praesepe). In May 2022 the Friends learnt that the freehold had been sold to new owners. The Friends have heard verbally from one of the new owners and are expecting further dialogue in the coming months. #### The Friends of Streatham Hill Theatre

The Friends of Streatham Hill Theatre's mission is to help find a sustainable solution to the future of the building, and to promote returning it to use as an arts and culture venue. They are an entirely volunteer-run organisation with around 1200 members and associates, supported by the Mayor of London, Lambeth Council and The Theatres Trust, and in February 2021 were granted CIO charity status.

#### Patrons

On the 91st birthday of the opening of the theatre, on 20th November 2020, the Friends announced nine Patrons for their campaign: Baroness Floella Benjamin, DBE, DL, Catherine Russell, Jessica Thom, Paul Merton, Renato Balsadonna, Robert Glenister, Samira Ahmed, Simon Callow, CBE and Sir Mark Rylance.

In January 2021 it was announced that they were being joined by Akram Khan, MBE. In addition, over 200 creative industry individuals and organisations have so far given their support to the campaign and many others continue to add their names.

#### **Community support**

The <u>Lambeth Local Plan 2021</u> says "The council will support the regeneration of the former Streatham Hill Theatre to become a major leisure and entertainment venue alongside workspace for creative and cultural industries".

The Streatham Investment and Growth Strategy 2019–2030, adopted by Lambeth, sets out a priority action to explore the feasibility of refurbishing and rejuvenating the theatre, and says that successfully restoring this building would bring significant improvements to the public realm and historic/cultural fabric of the area.

The Save Streatham Hill Theatre crowdfunding campaign to support a viability study and economic impact assessment was launched on 28th January 2020. It gained a huge groundswell of support from the local community, political leaders, and businesses, as well as support from the wider creative and heritage communities. It reached its funding target on 13th May 2020, along the way gaining funding pledges from the Mayor of London and Lambeth Council to help reach a total of £41,680, as well as a £6,000 grant from the Theatres Trust.
